INSTRUCTIONS:

Telecommunication companies that had not previously been subject to taxation under CGS § 12-80a should use Section One below to report Code 21a and Code 21b equipment. All other types of property should be reported in the appropriate category on the Declaration of Personal Property.

Telecommunication companies that had been previously subject to taxation under CGS § 12-80a should use Section One for equipment that was not fully depreciated as of October 1, 2009. Section Two should be used for equipment that was fully depreciated as of October 1, 2009.

The total depreciated value for Section One & Two should be entered on the Summary Sheet under Net Depreciated Value for #21.

SECTION ONE – Telecommunication equipment including equipment owned by companies subject to taxation under CGS § 12-80a and NOT fully depreciated as of October 1, 2009.
