Article 5 Consideration of Bids

Add the following paragraph:

**“§ 5.3.2.1 The Bidder shall submit amounts for all items on the Form of Proposal, including the total sum, the Cost of the Construction of the Roof Replacement, and the Cost of the Construction of the Entrance Canopy of SECTION FOP - Page 1 of 5, all of the UNIT PRICES ITEMS, all of the ALLOWANCES, and all of the ALTERNATES. Failure to do so is sufficient grounds for rejection of the Bid.**

**In the event of a discrepancy or math error on the Form of Proposal, the Town of Newington reserves the right to accept the amount that is in the Town’s best interests, even if this amount alters or changes a stated lump sum amount and/or the stated total sum identified by the Bidder on the Form of Proposal SECTION FOP - Page 1 of 5.**

**The Town is under no obligation to accept any ALTERNATE or ALLOWANCE amount on the Form of Proposal.”**
