**I. ROLL CALL**

Town Planner Paul Dickson called the roll with the presence of the above members noted.

**VIII. OLD BUSINESS**

**A. Open Space Commission Priorities and Future Work Discussion**

Mr. Dickson stated, that at the last meeting on October 10, 2024, the Natural Resource Inventory was a primary topic of discussion for the meeting. Mr. Dickson and the Committee discussed potential paths forward for the Natural Resource Inventory. The potential path forward includes staff review of property in town and considerations of zoning regulations to see what zoning mechanisms might be used for protections of open land. Hiring graduate interns to work on this Inventory initiative was also discussed.

Commission Member Budrejko shared with the group, a manual on collecting Natural Resource Inventory from the Hudson Valley NY website. She stated that the group will need short and long term goals.

Mr. Dickson asked that Commission members forward any other documents to him so that they can be collected and reviewed at the next meeting. He also suggested that a Purpose Statement be drafted to begin discussion of the scope of the project.

It was suggested that once the Natural Resource Inventory was available, it could be provided to developers so that they would be aware of the Town' and residents' priorities.

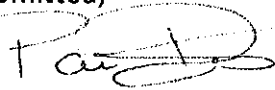
