**VI. CHAMBER OF COMMERCE REPORT**

Commissioner Lapierre reported that the main focus of the Chamber presently is the Bingo scheduled for January 30, 2026 at the Portuguese Club.

The past year has seen growth for the Chamber with membership approximately in the  $\pm$  200's.

Chairman Reny reviewed the items under Old Business for the new members to bring them up to date on the Commission's activities throughout the past year.

Welcome Letter: Letters have gone out to sixteen businesses acknowledging their commitment to the town over the years, for example, Morensen's, just completed 112 years in town. Erik is looking to send additional letters, approximately 16 by the end of January before starting on the new businesses, thanking them for locating in town. Members are asked to be responsible for acknowledging businesses by personalizing the letters. A list can be sent out itemizing the businesses that haven't been recognized yet.

Passport Program: Can be removed from the agenda since the program was completed in 2025 and was the second year of the program. The tracking of the participating businesses was done this past year and will be available for the program in 2026. It was suggested that the businesses who participated should receive a survey type letter asking if they are willing to participate again in 2026 and will relieve the necessity of contacting each business again if the participants agree to take part. The program is scheduled around Small Business Saturday and this past year scheduled for three weeks before the end of the program and the announcement of the winners of the donated prizes. In 2026 additional flyers for each business should be given to the participants to encourage more participation from the public, make them more aware of the program.

Hobby Odyssey: This grew out of Covid where people were more isolated and the Hobby Odyssey was, for example, for the month of February the hobby is yoga. So any where in the town where yoga was happening should be promoted, and then if you like wine, are the restaurants going to do something to bring the wine lovers together, so utilizing the businesses in the community together.

Town Branding: The difficulty of this item is that the town website might interfere with the program of branding. The EDC cannot have a social media presence since there is no

administrator to vet items posted on the website. Commissioner Gillan has tried to establish a visitor type page, looking to have a tourism focus Newington page. Looking to promote the businesses in town, promoting the benefit of living in Newington. There has been a logic model based on input from various entities, going through what is required, the budget necessary, and the long term and short term goals. Once there is an idea, a presentation to the Town Council can be made and see if they buy into the program and allocate time for a grant proposal if that type of funding is available. This type of project should have an Economic Development director, either full or part time to coordinate all of the information required.

The Town Manger has attended some of the EDC meetings, and is aware of some of the projects in addition to meeting with Erik, and is very responsive and helpful.

Erik updated the Commission on recent business changes in the town; Price Shopper rebranding to Market 32 and opening at a new location in approximately June, closing the present store; the convenience store at Robbins and Willard will be changing to a liquor store; Prime Burger requesting a change in the liquor license to accommodate live entertainment; Progressive Insurance becoming Attention to Detail and remodeling the canopy at the present location

All of the activities previously held received a good turnout of participants and some type of spring/summer "stroll" should increase the foot traffic in the center.


**XII. ADJOURN**
