Chapter 121

Voting Districts

§ 121-1 Districts established.

The Town shall be divided into seven voting districts, the boundaries of which shall be as shown on the map entitled "2022 Town of Newington Voting Districts," which is appended hereto.

§ 121-2 Polling places.

Polling places for the various voting districts will be at the following locations:

District #1-Mortensen Community Center

District #2-Ruth Chaffee Elementary School

District #3-Anna Reynolds Middle School

District #4-Elizabeth Green Elementary School

District #5-John Patterson Elementary School

District #6-John Wallace Middle School

District #7-Martin Kellogg Middle School
