But I've seen on Facebook that he was found not guilty and he was dismissed, and today's latest stuff is about the lawsuit, and I just don't feel as though this is the proper way that this should be going. I am not faulting anyone here. If you take away anything at all from this, you should go back to the Town Council and say something has to be done. The way the appointments were made, I found that very disturbing. The way the whole thing has gone is very disturbing to me. It seems that the Respondent has more rights than the Claimant.
