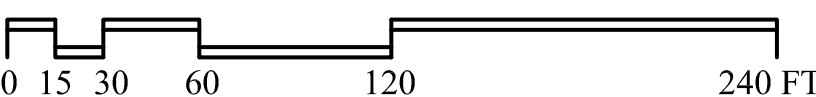




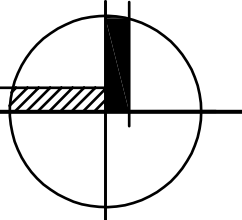

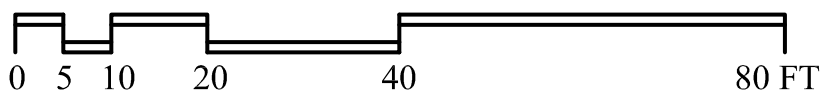

ENLARGED SITE PLAN - POOL AREA

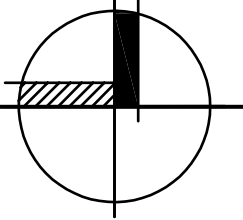

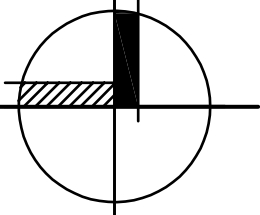
ENLARGED SITE PLAN - COURTS AREA

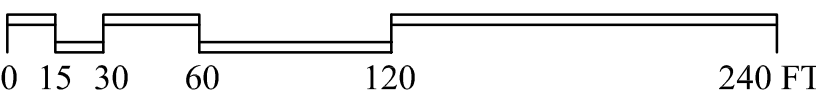






- PARK LOOP - 1 1/2 MI
