PURPOSE: **Pedestrian Accommodations**

A. Comments/Open Discussion

1. Project No. 0093-0218 will upgrade fifteen (15) state-owned signalized intersections along Route 175 (Cedar St), S. R. 505 (Fenn Rd), and Ella Grasso Blvd in Newington and New Britain and interconnection of the intersections as a coordinated traffic signal system. There is a need to improve traffic flow along this corridor and in order to accomplish this need many of the traffic signal appurtenances require replacement. It should be noted that, many of the traffic signal control cabinets, steel span poles, signal heads, and related equipment at these intersections are over twenty (20) years old, have surpassed their life expectancy and do not meet current MUTCD and ADA standards. The existing intersections are not interconnected with copper or fiber and a majority are currently coordinated via time-of-day timing plans. 2. This project was identified as an Early Deployment Need as part of the Statewide CTSS Needs Assessment as Route 175 (Cedar St), S. R. 505 (Fenn Rd), and Ella Grasso Blvd will likely serve as a critical alternative route for future work along the I-84 corridor.
3. The project will include the installation of fiber-optic transmission cable from the field equipment directly back to Connecticut Department of Transportation (CTDOT) Newington HQ. The project will also install new CCTV cameras along the road segments that will allow for monitoring of diversion routing congestion by CTDOT staff.
4. CTDOT is also considering adaptive traffic signal technology for this corridor.
5. The following MUTCD compliant pedestrian accommodation options were discussed with the Town for various intersections.
 - a. Exclusive Pedestrian Phasing
 - b. Concurrent Pedestrian Phasing
 - Lead Pedestrian Interval
 - c. Removal of Pedestrian Accommodations. This option requires the

following:

- Town concurrence
- CTDOT Traffic Engineering report for Office of State Traffic Administration (OSTA) review and approval
- Town endorsement of report
- Removal of Concrete Ramps and Pedestrian related traffic signal appurtenances (as necessary) identified in the Project 0093-0218 design plans.
- Installation of “No Pedestrian Crossing” sign under State Project 0093-0218 (required only for crossing artery).

6. The main purpose of this meeting was to determine the preferred pedestrian accommodations at each of the fifteen (15) signalized intersections in the project. A spreadsheet was handed out that summarized the existing pedestrian accommodations (appended with the sign-in sheet). Google Earth was also utilized during the meeting as each intersection was being discussed. All attendees discussed each intersection in detail before agreeing to the preferred pedestrian accommodations summarized below.
