
Library Champions become sustaining donors by making monthly, quarterly or annual gifts of a recurring amount. You decide the amount that will work best for you

Year End Giving

Donations received in the 4th quarter of 2024 will help with expenses for the first phase of this project. Year-end giving is important because it provides an opportunity to donate to qualified tax-exempt organizations, and those contributions may be tax deductible.

Anyone owning appreciated stock can make a larger charitable impact by gifting stock and/or donating long-term appreciated securities, including stocks, bonds, and mutual funds, directly to the Lucy Robbins Welles Library. Compared with donating cash, or selling your appreciated securities and contributing the after-tax proceeds, you may potentially donate more and avoid capital gains on the sale of stock by donating in kind.

If you're 70 ½ or older, you can contribute to the Lucy Robbins Welles Library from your IRA and potentially receive tax benefits. Check with your IRA administrator on how a Qualified Charitable Distribution (QCD) may help satisfy your IRA's 2024 required minimum distribution (up to \$105,000) and for assistance to implement a QCD and other options.
