## **APPLICATION FOR SIGN PERMIT INFORMATION**

1. Must have drawings or a picture of the proposed sign showing size, color, lettering, etc.  
If the sign will be mounted, please show attachment detail.
2. We will need a Zoning Permit Application for wall signs and free-standing signs. Free standing signs will also need a plot plan or site plan showing where the sign will be installed.
3. If the sign is illuminated, an Electrical Permit Application is required to accompany the Sign Application. Provide UL listing or E Registration number of manufacturer.
4. No license is needed for installer, only for the electrical contractor.
