This form must be completed and returned to the assessor's office *annually*, not later than December 31<sup>st</sup>, next following the date the tax is due. The assessor may require that you submit information verifying a motor vehicle lease. **Failure to file this application by the deadline constitutes a waiver of the right to claim the property tax exemption or refund under 12-81(53). The vehicle MUST be owned or leased by the Service Member or Spouse.**
